 - sent a letter to President Mahoney and the approval is planning to vote on May 3rd in Moon Library - voting members included Research Project Assistants and Research Aides
- i. GSA support of GSEU Living Wage Campaign Emme
 - i. this was sent out within the last two weeks
- j. Benefits of Student Leader Meeting Emme
 - i. meeting again next week and have so far agreed that all of these things are doable
 - told her that it feels like graduate students are being exploited by the administration and are expected to fix the problems that are way above our scope
 - 2. MOSA Senate would be good people who are able to register early like Honor's students to work around the schedule of planning events for the undergraduate students
 - advocating for a concession on student fees for Senate members started with all Senate members and if not compromised for Executive members (5 from GSA and 6 from MOSA)
 - 4. Administration needs to be the ones planning the Executive Mixer MOSA shouldn't need to be using their budget
 - administration trying to get College Hour back on the agenda Marshall is not in use, but Illick is up next and then another building - there is not enough rooms
