 - 1. Engagement is the most important aspect currently
 - 2. Emails are going to be sent out throughout the week
 - ii. Research and Scholarship Funds
 - 1. Successfully launched
 - Grad School and ORP have committed \$5000 each to support grants and awards
 - Committed to some support on a per semester basis contingent to other obligations that these offices need to meet
 - 4. Improve the grants and awards landscape for grad students more awards in general and more substantial awards overall
 - 5. Want to make a difference to the lives of the grad students
 - a. 7 travel grants per semester at \$500 each (instead of \$200)
 - b. Average 6 PD grants at about \$600 each (usually comes in below budget because the number of applicants is usually small)
 - c. 5 research grants at \$1000 each (moving up from 3 at \$500 each)
 - d. 10 special awards at \$200 each (up from 10 at \$175 each)
 - e. New award named after the first president of the GSA 1 per year at \$1500
 - GSA founded November 6, 1931 Robert Cockrell Award for All-Rounded Graduate Student
 - Engage faculty as blind reviewers ORP and Grad School will maintain a list of faculty members - engage three per semester who will review based on a rubric that we give them and we make the final decision as the GSA
 - iii. SAF
 - 1. Whereas clauses hasn't changed
 - 2. Proposing an increase to continue supporting GSA programming with explicit use of increasing available grants and awards to the student body
 - 3. SU change from \$10 to \$15 (proportional increase from what they applied to their students) per semester

- a. Confusion about some of what ESF students can access via these fees - programming through Bird Library, SU legal services, SU Graduate School Resources (career coaching and support for CVs, grants and awards - no access to their grants however), GSO Social Events
- Need better distinction from what GSO Fees offer us versus what our contract with SU through ESF offers us - address these concerns first and then revisit the increase at some point next Spring
- 5. Proposal to have students pay GSO directly only \$1 per semester and account for the SU GSO fee in the increase that the GSA fee goes by then GSA would pay GSO the activity fee directly (whatever remains after the \$1)
- 6. Change begins in Fall 2024 full time students paying \$84.42, part time pays \$9.38 per credit hour, all students pay \$1 to GSO grants and awards will always come first with this increase in SAF
